  - Any other suggestions.

# What is an Integrated Water Use Licence Application (IWULA) and what does a IWULA contain?

The NWA prescribes the processes to be followed when compiling a WULA, in respect of Section 21 activities that form the legal basis of this authorisation and identifies the relevant competent authority, the Department of Water and Sanitation (DWS).

The purpose of this WULA is to assess all the required water uses for the Tafelkop Mall in terms of their extent, duration, intensity and significance relating to the specific activity and to ensure that there are sufficient water resources available for the activity, while taking cognisance of other water users needs including the environment. The process aims to ensure that all relevant factors are considered when evaluating the potential impacts of a project on the water resource, as well as developing appropriate management measures to mitigate these impacts.

#### 1 BACKGROUND AND PROJECT DESCRIPTION

Tafelkop Mall (Pty) Ltd is proposing to build a shopping mall (Tafelkop Mall) located within the town of Tafelkop, Sekhukhune District Municipality in the Limpopo Province, South Africa. This area falls within the jurisdiction of the Elias Motsoaledi Municipality. Tafelkop is a settlement about 20km northeast of Groblersdal, Limpopo South Africa. The area is characterised by small settlements with a limited supply of formal retail facilities.

Tafelkop Mall will boasts over 134 shops, which include restaurants and service outlets. There is a notarial lease between Tafelkop Mall (Pty) Ltd and Tafelkop Retail (Pty) Ltd.

GCS Water and Environment (Pty) Ltd (GCS) were appointed by Fontis Development (Pty) Ltd to undertake the licensing process required to authorise water uses triggered in terms of Section 21 of National Water Act, 1998 (Act No. 36 of 1998) (NWA).

In compliance with the requirements of the NWA, Tafelkop Mall (Pty) Ltd is in the process of applying for a Water Use License (WUL) from the Department of Water and Sanitation (DWS) for water uses triggered in terms of Section 21 of the NWA. The following water uses have been identified and are being applied for as part of the Integrated Water Use License Application (IWULA) (See Table in Section 2):

- Section 21(a): Taking of water;
- Section 21(b): Storage of water; and
- Section 21(g): Disposing of waste in a manner which may detrimentally impact on a water resource.




Figure 1.1: Locality Map

#### 2 INTEGRATED WATER USE LICENCE APPLICATION

#### National Water Act, 1998 (Act No. 36 of 1998) (NWA)

Water uses are identified in terms of Section 21 of the NWA. Any activity which is considered a water use may be undertaken if it is; a Schedule 1 use (e.g. abstracting groundwater for domestic use), a continuation of an existing lawful water use (a water use which took place between 1996 and 1998); which is permissible under the General Authorisation notices; or if a IWULA is issued for that water use by the DWS.

In order to apply for the water use associated with the proposed project, an IWULA needs to be compiled and submitted to the DWS. In this case, Tafelkop Mall (Pty) Ltd has to apply for a Water Use License (WUL) because of the water use that is triggered by the project.




Figure 2.1: Proposed Water Use Locality

The following water use requires authorisation for the IWULA in terms of Section 21 of the NWA (Figure 2.1):

National Government has the overall responsibility for and authority over water resource management, including the equitable allocation and beneficial use of water in the public interest. A person can only be entitled to use water if the use is permissible under the NWA. The purpose of the IWULA is to identify and assess the potential environmental and socio-economic impacts associated with the project, to develop measures to manage and/or mitigate the negative impacts, and to enhance any potential positive impacts. The application further enables the DWS to process and make an informed decision with regards to the water resource and management thereof in the area where the project is located.

#### 3 PUBLIC PARTICIPATION PROCESS

The required Public Participation Process (PPP) is outlined in the Government Notice Regulation No. 267, Regulations Regarding the Procedural Requirements for Water Use Licence Applications and Appeals published in Government Gazette No. 40713 on 24 March 2017. The Public Participation Process (PPP) is an important part of the authorisation process.

The key objective of public participation is to assist stakeholders to identify issues of concern, to make suggestions for enhanced benefits, and to comment on the findings of the IWULA.

Proposed steps in and scheduling of the process are as follows:

#### Step 1: Notify I&APs and identify issues

- a) Notify Interested and Affected Parties (I&APs) of the project;
- b) Provide I&APs with a Background Information Document (BID) on the project, including a locality map and a Registration and Comment Sheet;
- C) I&APS are required to register their interest in the project to receive further project information; and
- d) Identify any issues/concerns and/or suggestions of I&APs with regards to the project (to be addressed and recorded in the Comment and Response Report).

#### Step 2: Public review of draft documentation

The draft IWULA will be placed for public review for a period of 60 days. All registered I&APs of the project will be invited to review and provide and comments or queries on the report.

#### Step 3: Final Integrated Water Use Licence Application IWULA

The Final IWULA, including the Comment and Responses Report and will be compiled for submission to the DWS for decision making.

#### Step 4: Notify I&APs of the Authorisation and Appeal Period

All registered I&APs will be notified in writing of the authorisation for the project and the appeal period, as well as the manner of appeal.

#### 4 BE AN INTEGRAL PART OF THE ENVIRONMENTAL MANAGEMENT PROCESS

Public involvement is an essential part of any environmental assessment process. You have been identified as an I&AP who may want to receive information regarding the above-mentioned project and will be allowed to provide your input into the environmental assessment process. All comments will be recorded and presented to the project team and regulatory authorities. You will receive feedback on how your comments have been taken into account and the outcome of the assessment.

I&APs include any person who will be directly or indirectly involved and/or affected by the project. To be recognised as an I&AP you must register with GCS Water and Environment (Pty) Ltd to be added to the stakeholder database for the project. You may communicate via fax, email or telephone to obtain further information or comment on the proposed IWULA (please see contact details below). All registered I&APs will be kept informed of the decision taken by the DWS.

### How do you get involved?

You can get involved in the following ways:

- By registering your interest in the project with GCS as indicated below;
- By responding to our invitation for your involvement advertised in the local newspaper;
- By completing and forwarding the Registration and Comment Sheet to GCS if you have a query, comment, or require further project information;
- By telephonically contacting GCS; and
- By reviewing and commenting on the various reports within the stipulated comment period.

#### **Public Notification**

A major part of the PPP is to notify members of the public of the proposed activities, particularly those who may be directly or indirectly affected by the proposed project. This will be achieved via the following means:

- The placement of an advertisement in a local newspaper;
- Notices, which will be placed at and around the project area;
- Electronic distribution of BIDs to landowners and occupiers of land adjacent to the project area and to I&APs on request; and
- Written notifications to Local authorities, who will be automatically be registered as I&APs.
